COMPLETE THE REQUIRED 90 HOUR SALESPERSON'S COURSE

This course consists of 18 modules. The Arizona Department of Real Estate (ADRE) limits the number of class time hours a student may attend per day to 10 hours for pre-licensing. Two courses per day are presented. Once you have completed the 90 hours of required education, you can take the school exam. You must pass with a 75.0% rate before being eligible for the State Exam.

ADDITIONAL REQUIREMENTS FOR LICENSING:

COMPLETE A 6-HOUR CONTRACT WRITING COURSE (Boot Camp) which is included in your tuition.

APPLY AND OBTAIN YOUR FINGERPRINT CLEARANCE CARD FROM THE DEPARTMENT OF PUBLIC SAFETY (DPS)

The school recommends Arizona Livescan Fingerprinting. Go to and select a location near you; chose a convenient appointment time and plan for about 20 minutes. Their charge covers the DPS \$67 fee and provides electronic fingerprinting for faster processing. School policies



Our Facility

We hope you enjoy our facility. Students have access to the conference center / training room, guest center; our guest wi-fi; cell phone recharging; common area restrooms; and outdoor smoking area. Our classroom is modern, spacious and has easy access.

Non-Smoking Facility

Please note that State law prohibits smoking within 20 feet of entries and exits. Ashtrays are provided for your convenience located near the entrance and at the west end of the building.

Parking

Uncovered spaces are available to the students at the front of the building.

Disability/Special Needs

All areas of the building are handicap accessible. If you need assistance, please let us know.

Health, Office and Classroom Hygiene: Tucson Real Estate Academy maintains sanitary conditions in the building and takes prudent measures regarding the safety and well-being of its employees and customers to restrict the risk of exposure to seasonal viruses and bacteria.

Course Content: This course satisfies the Arizona Department of Real Estate requirement for the 90 hour Salesperson's pre-licensure requirements. The course consists of 18 modules and a 150 question school exam. Classroom materials will be distributed upon attendance at the first class.

Protected Material: All material, print and intellectual, is copyrighted and vigorously protected. Duplication and/or distribution is prohibited and punishable under the laws of copyright.

Transcripts: The first student transcript is available upon completion of the course and upon request. Additional transcripts are available for a \$50.00 fee per transcript.

Classroom Rules:

Cell phones: Cell phone use in class is prohibited unless the instructor has you research a term or topic. Phones are silenced and not visible until break times.

Laptops/tablets: Laptops or tablets may be used for note taking purposes only and must be verified and allowed by class instructor. If allowed, please be courteous to others and silence the keys. Typically, once approved, use of a laptop/table requires sitting at the front of the room.

Food: Quick energy snacks are allowed. Please avoid food in noisy wrappers and/or unpleasant odors. Containers with lids are allowed for beverages.

Recording: Recording of the course sessions is prohibited. All material received is copyright protected and is for your use only.

Recruiting & Solicitation: Instructors and students are prohibited from soliciting or recruiting in our classroom. If you have questions about placement or connecting with brokerage firms, please contact the school administrator, Marti Barnewolt. Marti@tucsonrealtors.org.

Payment: Full payment for the course is required upon registration. The school requires written acknowledgement and acceptance of this AGREEMENT prior to attending the first class. Accepted forms of payment include cash, credit or debit from MasterCard, Visa or Discover. Payment can be made on the school website www.tucsonrealtors.org under the Professional Development tab. Personal checks are accepted as well, however, checks returned for insufficient funds are subject to bank charges and a \$50.00 processing charge to the school.

Purchase of the pre-licensing course is good for the 3 following months with renewal options available at the full discretion of the school administrator, Marti Barnewolt.

Refund Policy: Cancellation will result in refunds as follows:

1. Prior to materials being dispensed and class attendance, 100% refund minus a 15% cancellation fee.
2. Once classes are being attended and materials have been dispensed there is no refund.

In the event of a missed class, check with the school administrator for make up opportunities that may be available. Your tuition may cover this within 3 months of your first class. Following this period of time, full tuition at the existing price will be charged.

Inside the classroom



CLASSROOM

This course is presented live, in the classroom. Every time we meet, the presentation will include key points in lecture, supported by powerpoint including graphics and illustrations to drive concepts, role playing, end of module quizzes and quiz review; working mathematical calculations and Q&A with a focus on law, rules and professional behaviors. Following completion of the course the school exam is scheduled to be completed. The exam consists of 150 questions. Pass score is 75.0%; candidates are allowed to test as often as necessary to pass. Upon completion, you may schedule the Pearson Vue State Exam.

SCHEDULING THE SCHOOL EXAM

The school exam may be taken according to the school's schedule which is provided just prior to completion of the course. The Arizona Department of Real Estate requires that the exam be taken in person and proctored. The exam is provided in the same location as your classes. A schedule of test days will be provided 2 days before your class ends.

You will need to bring an active government issued photo id and a basic 4 function calculator. You will not be allowed to have your cell phone with you. The exam is 150 questions and you will be allowed up to 4 hours to complete.

You are required to achieve a 75.0 % correct answer score to receive the Certificate of Completion.

A lower score will require you to schedule for exam #2. Only one test per day may be taken. Review of a failed test can be provided upon scheduling.

Once you pass the school exam, you will be issued Certificate of Completion and the Pearson-Vue Real Estate Candidate Handbook which will provide instructions for scheduling and paying for the State Exam.

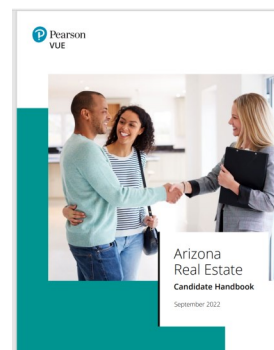
